# **KERRY HAGGARD SENTENCED**

Two years ago, the movie poster community was rocked by the accusations that well-known poster collector Kerry Haggard had created and sold high-end fraudulent movie posters. These posters were reportedly so well done that they fooled even some of the most knowledgeable and experienced collectors and dealers.

Haggard was subsequently arrested, pled guilty to one count of mail fraud, and has now been sentenced. The following is the official press release of the United States Attorney General.

#### GEORGIA MAN SENTENCED IN MANHATTAN FEDERAL COURT TO 78 MONTHS IN PRISON FOR SELLING FAKE VINTAGE HORROR MOVIE POSTERS AND LOBBY CARDS OVER THE INTERNET

**April 9, 2012 - New York** - Preet Bharara, the United States Attorney for the Southern District of New York, announced that KERRY HAGGARD, 47, of Commerce, Georgia, was sentenced today to 78 months in prison for selling horror movie posters and lobby cards which he represented over the Internet and elsewhere were authentic vintage collectibles, but were in fact fakes. HAGGARD pled guilty to one count of mail fraud on October 24, 2011, and was sentenced today in Manhattan federal court by U.S. District Judge Colleen McMahon.

According to the complaint and the Indictment to which HAGGARD pled: The film industry first introduced posters and lobby cards for horror movies in the 1920s. Both were displayed in the lobbies of movie theatres and became popular collectible items that are often sold through auction houses and over the Internet through online auction sites such as eBay.

From January 2006 to August 2009, HAGGARD engaged in a scheme to defraud collectors by selling purportedly vintage horror movie posters and lobby cards that he represented were original pieces, knowing that the items were reproductions he had created himself. HAGGARD used a New York-based printing company to make high-quality copies of horror movie cards or posters from either hard copies or digital scans of pieces he provided. HAGGARD also used a restoration company to attach the copies to lobby card stock and alter the resulting product to make it look as real as possible.

HAGGARD then fraudulently marketed the reproductions as originals through eBay. He was able to sell numerous fake lobby cards and posters for movies such as Frankenstein" and "Son of Frankenstein," at prices ranging from \$500 to \$5,000, to approximately 25 victims. In other instances, HAGGARD traded his fake reproductions to other sellers who gave him real lobby cards and/or posters in return. The victims learned of the fraud in various ways, including after providing the lobby card to a restoration expert, or after consigning the piece to a large auction house for sale.

Although the defendant was released on bail after his arrest in April 2010, he was rearrested and remanded in March 2011, upon order of the Court, after the FBI learned that HAGGARD was attempting to enlist the assistance of an individual to hide items that were part of the fraud from the FBI and from his victims. The FBI recovered several pieces believed to be part of HAGGARD's fraud. Then, even while in jail, HAGGARD continued secreting assets and items from the fraud, enlisting the assistance of his girlfriend and son in doing so. The FBI recovered several of these pieces as well.

As a result of HAGGARD's fraud, his victims lost more than \$1.3 million in money and property. HAGGARD's interest in the recovered pieces has been forfeited to the United States.

It is anticipated that proceeds from the sale of those pieces will be used to compensate HAGGARD's victims.

In addition to the prison term, Judge McMahon sentenced HAGGARD to three years of supervised release, imposed a \$1.38 million forfeiture judgment, imposed a restitution order for \$1.38 million, and ordered him to pay a \$100 special assessment fee.

Mr. Bharara praised the Federal Bureau of Investigation for its outstanding work on the case.

The case is being prosecuted by the Office's Complex Frauds Unit. Assistant United States Attorney Ryan P. Poscablo is in charge of the prosecution.





#### The Berwick Discovery Of Lost Movie Posters Brings \$503,000+ To Lead \$1.93+ Million Heritage Auctions Event

1931 Dracula Style F one sheet brings \$143,400; Cimarron one sheet realizes \$101,575; March 23-24 auction in Dallas sees strong, steady results

DALLAS, TX: *The Berwick Discovery of Lost Movie Posters* – a trove of 33 classic and incredibly rare posters dating back as far as 1930 – many examples of which were thought to be lost for all time, realized \$503,035 total, more than double its pre-auction estimate of \$250,000+ to lead Heritage Auctions' \$1.93+ million March 23-24 <u>Vintage Movie Poster Auction</u>. The auction realized a sell-through rate of 97% by value.

<u>A rare 1931 Dracula Style F One Sheet</u>, which sold to an anonymous overseas collector, led the auction with a price realized of \$143,400. One of the biggest surprises of the collection was <u>the \$101,575 price realized for the</u> <u>stunning and scarce movie poster for 1931's *Cimarron*</u>, the first Western to win the Best Picture Academy Award. All prices include Buyer's Premium.

The Berwick posters came out of an attic and were found in a small country auction in Berwick, PA, in several lots stuck together with wallpaper paste, which had preserved them for more than eight decades.



"We knew this was something special when they came in the door," said Grey Smith, Heritage's Director of Movie Posters, who spent two weeks carefully steaming the posters apart for restoration. "Many of these posters had never been seen before – this really is film history and collectors realized that."

The <u>1931 Style F one sheet for the Universal horror classic Dracula</u>, which realized \$143,400, is only the fourth Style F poster from the film ever uncovered. Two previously unseen versions of movie posters from the 1931 film *The Public Enemy* were also the object of intense collector attention. <u>The Style B Public Enemy poster brought \$59,750</u>, while the other Public Enemy movie poster, featuring James Cagney, realized \$55,269, while the style B poster for 1931's <u>Little</u> <u>Caesar</u>, featuring Douglas Fairbanks Jr., one of only two known, realized \$41,825.

Stagecoach (United Artists, 1939): One Sheet, realized: \$56,763.

Casablanca (Warner Brothers, 1942): One Sheet, realized: \$28,680.

My Man Godfrey (Universal, 1936): One Sheet, Style C, realized: \$28,680.

Tarzan and His Mate (MGM, 1934): Lobby Streamer, realized: \$26,290.

The Little Giant (First National, 1933): One Sheet, realized: \$21,510.

### **TARZAN CELEBRATES HIS 100TH BIRTHDAY**

*Tarzan of the Apes* was first released in the October 1912 issue of *All-Story* magazine, earning author Edgar Rice Burroughs \$700.00. It went on to become a book in 1914.

In August of 1917 an eclectic band of filmmakers, actors and circus acrobats fought malaria, unbearable heat and the swamp of the Louisiana Atchafalaya River Basin to bring to the silver screen this best-selling book. It was an instant hit with audiences, considered one of the top six motion pictures of the silent era, and one of the first 10 films to earn over one million dollars at the box office. The film was shot in Morgan City, Louisiana and is the subject of a documentary film produced by Al and Allison Bohl of Bossier City, Louisiana titled *Tarzan: Lord of the Louisiana Jungle* Festival.

We were very happy to provide some background details and images on the movie posters and other ad information that was used in the film. Al and Allison did an excellent job. (For anyone interested in Tarzan and/or silent era films, this documentary is a must. You can get a copy <u>HERE</u>.)



The City of Morgan City, along with the Edgar Rice Burroughs Foundation, recently hosted the Tarzan: Lord of the Louisiana Jungle Festival, to both mark the 100th year celebration and to premiere this great documentary.

We were very happy to participate in the festival. We had a table exhibit with our books (including Hollywood on the Bayou, Learn About Movie Posters, Learn About International Movie Posters, and Movie Still Identification Book) and well as our Louisiana prints.

These events are excellent opportunities to cultivate new movie poster collectors. We also met the granddaughters of Edgar Rice Burroughs as well as the archivist for their great foundation.
